## GENERAL REGULATIONS

- (a) Entries must be received on the Society's form by the closing date and accompanied by the proper fees as specified in the schedule. Nominations not accepted.
- (b) Membership at a cost of £17.50
- (c) All exhibits must have been the bona-fide property of the exhibitor for two calendar months previous to date of entry.
- (d) All exhibitors should ensure they are acquainted with the Society's Rules & Regulations.
- (e) Horse Exhibitors must bring Passports and Vaccination Certificate to the Show. Spot checks of Passports and vaccine Certificates will be made on Show Day.
- (f) Any exhibitor that is prevented from attending the Show due to cancellation of classes will be given a full and immediate refund.
- (g) Riding hats must comply with the current safety standard and be worn by riders at all times when mounted.

**PLEASE NOTE THE UNDERMENTIONED NUMBER OF PASSES WILL BE SENT TO EXHIBITORS. IF YOU REQUIRE ANY FURTHER PASSES FOR EXTRA ATTENDANTS, THESE MAY BE PURCHASED AT £12.00 EACH.**
